ORDINANCE NO.

AN ORDINANCE relating to fees charged and collected on behalf of the Stadium Enterprise Fund; formally establishing fees for parking and public tours at the Kingdome.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Chapter Intent. It is the intent of the King County council to formally establish fees for parking and public tours at the King County Kingdome. The fees will be charged and collected by the department of stadium administration.

SECTION 2. Effective Date. The effective date of this ordinance is January 1, 1985.

SECTION 3. Definitions. For the purpose of this chapter:

- A. "DAYS" means that period of time from 5:00 a.m. to 5:00 p.m.
- B. "EVENINGS" means that period of time after 5:00 p.m. to 12:00 a.m.
- C. "EVENT DAY" means any calendar day on which there is a scheduled business banquet, recreational, trade, community, entertainment, or sporting event in the Kingdome for the benefit of the public or a private group.
- D. "NON-EVENT DAY" means any calendar day on which there is no scheduled business banquet, recreational, trade, community, entertainment, or sporting event in the Kingdome for the benefit of the public or a private group.

SECTION 4. Parking.

A. Daily Parking Fees

Any person parking a vehicle in the Kingdome parking lot on a daily basis will pay according to the following schedule:
