ORDINANCE NO. _____

AN ORDINANCE making a supplemental appropriation of \$20,600 to Airport Construction Project No. 001241, West Taxiway Overlay, and of \$16,777 to Airport Construction Project No. 001271, Perimeter Road Asphalt Overlay, from the Airport Construction Fund balance; and amending Ordinance No. 6597, Section 77, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$20,600 to C.I.P. Project No. 001241, West Taxiway Overlay, from the Airport Construction Fund fund balance.

SECTION 2. There is hereby approved and adopted a supplemental appropriation of \$16,777 to C.I.P. Project No. 001271, Perimeter Road Overlay, from the Airport Construction Fund fund balance.

SECTION 3. Ordinance No. 6597, Section 77, as amended, is hereby amended to read as follows:

From the several capital improvement project funds there are hereby appropriated and authorized to be dispersed the following amounts for the specific projects identified and contained in Attachment No. 1 of this ordinance as adjusted to include the specific project amendments listed within this section.
