Included in special programs is an executive contingency of ((\$225,564) \$122,364 which shall not be expended unless the county executive certifies in writing that funds are available and requests the county council adopt an additional appropriation ordinance; upon adoption, such funds may be expended for the purpose specified.

- 1. Up to \$239,676 is reserved in the executive contingency for 18.8 positions (9.4 FTE's) to staff one residential floor in the new jail, should inmate population levels require its use.
- 2. \$10,000 shall be used as a reward for information leading to the identification and prosecution of the Green River murderer.
- 3. Alcoholism. \$181,042 shall be held in executive contingency in special programs pending the development of a revised division budget.
