10	certain property described in the building and land development file no. 229-84-1
11	SECTION 2. The recommendation of the zoning and subdivision examiner to
12	reclassify the subject property from RS 7200
13	to RD 3600-P, subject to conditions (modified) is hereby adopted by
14	the council of King County. Those conditions, if any, which must be
15	before this ordinance becomes effective must be satisfied on or before
16	January 1, 1986 , or all authority granted by this ordinance shall
17	expire and this ordinance shall be of no further force or effect. The council
18	may extend this date by motion pursuant to KCC 20.24.230. Upon this ordinance
19	becoming effective, the building and land development division shall amend
20	the official zoning maps of King County to reflect this action.
