AN ORDINANCE appropriating supplemental funds of \$46,000 to CIP Project No. 002018, Outlying Building Remodeling, and \$460 to CIP Project No. 002055, 1% for Art Fund 331, from the Real Estate Excise Tax Fund; transferring \$10,000 from CIP Project No. 002017, Outlying Building Repair/Replacement, to CIP Project No. 002018, Outlying Building Remodeling; and amending Ordinance 6597, Section 50 and 77, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$46,000 to CIP Project No. 002018, Outlying Building Remodeling, from the Real Estate Excise Tax Fund, for the purpose of constructing a 445 square foot storage room and installing a private restroom in a jury room at the Federal Way District Court.

SECTION 2. There is hereby approved and adopted a supplemental appropriation of \$460 to CIP Project No. 002055, 1% for Art Fund 331, from the Real Estate Excise Tax Fund, for the purpose of covering art costs related to the work described in Section 1 of this ordinance.

SECTION 3. The King County executive is authorized to transfer \$10,000 of existing appropriation authority from CIP Project No. 002017, Outlying Buildings Repair/Replacement, to CIP Project No. 002018, Outlying Buildings Remodeling.

SECTION 4. Ordinance No. 6597, Section 50, is hereby amended to read as follows:
