ORDINANCE NO. _____

AN ORDINANCE making a supplemental appropriation of \$223,367 to Airport Construction Project No. 001274, 7300 Building Renovation, and of \$108,795 to Airport Construction Project No. 001275, Ellis Avenue Building HVAC, from the Airport Construction Fund fund balance; and amending Ordinance No. 6597, Section 77, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$223,367 to C.I.P. Project No. 001274, 7300 Building Renovation, from the Airport Construction Fund fund balance.

SECTION 2. There is hereby approved and adopted a supplemental appropriation of \$108,795 to C.I.P. Project No. 001275, Ellis Avenue Building HVAC, from the Airport Construction Fund fund balance.

SECTION 3. Ordinance No. 6597, Section 77, as amended, is hereby amended to read as follows:

From the several capital improvement project funds there are hereby appropriated and authorized to be dispersed the following amounts for the specific projects identified and contained in Attachment No. 1 of this ordinance as adjusted to include the specific project amendments listed within this section.
