

ORDINANCE NO. 7124

AN ORDINANCE relating to fees charged for the use of King County parks and recreation facilities; and amending Ordinance Nos. 5783, 6027, 6247, 6601, and 7015, and K.C.C. 7.08.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 5783 as amended and K.C.C.

7.08.040 are amended to read as follows:

Recreation services. Recreation services fees shall be:

A. Fee structured program

Class fees. . . . Range \$5.00 to \$50.00 per class.

A ten percent administrative surcharge not to exceed \$5.00 will be assessed per participant per registration on the class or event cost for all fee structured classes, special events, athletic fee programs, workshops, special events or seminars. This administrative cost will not be charged for regularly scheduled programs or events which are intended solely for the enjoyment of citizens 55 years or older.

B. Entry and tournament fees (Leagues, tournament and special events fees to include officials, awards, sports equipment, administration fees and association fees.)

Adult Men's/Women's Leagues. . . \$100-\$600 per team/
league

Adult Men's/Women's Tournaments. \$50-\$200 per team/
league

Individual dual sports events. . \$5-\$50 per participant

C. Adult field usage fees

- 1. Baseball/Softball Fields: . . . \$1.00 per participant
per game
Not to exceed \$10.00
per team per game
- Practice Fields \$2.00 per game/team/
league
- 2. Soccer/Football Fields: . . . \$1.00 per participant
per game
Not to exceed \$11.00
per team per game
- Practice Fields \$2.00 per game/team/
league
- 3. Basketball/Volleyball/Related
Gym Sports \$0.50 per participant
per game. Not to
exceed \$3.50 per team
per game

D. Athletic field lights \$6.00 per hour

E. Athletic field telephone

Reservation card \$10.00 per team per
season

F. Facilities Usage:

1. Group A - Activity Center Only

Includes meetings or activities that are promoted,
organized, managed, supervised and sponsored by civic or
nonprofit organizations such as community clubs, Orthopedic
Guilds, service clubs, and public meetings. If the activity
under sponsorship is open and free to the public and conforms
to the rules of the activity center, and is scheduled during
the activity center program hours, there is no charge.

2. Group B - Activity Centers and Community Centers

(For any organizations, groups and clubs, using an activity or community center during nonprogram hours, or, a community center at anytime during the day or evening the following fee schedule will be applied.)

((Basic-opening-and-closing-fee---\$15.00))

Gymnasium fee \$15.00 per hour (2 hour minimum)

Meeting room fee \$10.00 per hour (2 hour minimum)

3. Group C - Kitchen Use Fee

(All groups using kitchen facilities at activity centers and community centers for meal preparation or warmups, refrigeration, or similar activities will pay the following fee.)

Kitchen use fee \$5.00 per hour (2 hour minimum)

4. Group D - Gold Creek Lodge Use Fee

(Any group renting the facility for less than one day will use the Group B fee schedule. For groups using the facility for 24 hours or more the following fee schedule will be used.)

Youth Groups \$50.00 per day

Adult Groups \$100.00 per day

5. Group E - Outdoor Facility Use Fee

(Any groups renting outdoor facilities for activities including, but not limited to, dog shows, outdoor weddings, day camps, Fun Runs and organized picnics will pay according to the following fee schedule.)

1-100 participants \$10.00 per day

101 + participants 10¢ per participant per day

1 Any groups using outdoor facilities who charge a
2 participant fee will be assessed the above rental rate plus 10%
3 of gross revenue.

13. Group M - Damage and Key Deposits

For any organizations, groups, or clubs using an activity center or community center a damage and key deposit fee will be assessed according to the following schedule.

Damage deposit \$25 to \$200 fee
(determined by type of activity and number of participants)

Key deposit \$25 to \$50 (determined by type of activity and number of participants)

G. The effective date of K.C.C. 7.08.040 F.1. establishing "no charge" to civic or non-profit organizations for the use of activity centers shall be April 5, 1982, the date Ordinance 5935 was adopted by the council.
