ORDINANCE NO. 7153

AN ORDINANCE relating to the annexation of an area known as Milton Road South to Lakehaven Sewer District, amending Ordinance 6724, Section 4.

STATEMENT OF FACT:

- The King County Council held a public hearing on the above matter and approved it by Ordinance No. 6724 on March 19, 1984, as prescribed in RCW 56.02.060.
- 2. The Boundary Review Board held a hearing on the above matter on May 24, 1984 and deleted certain territory.
- This ordinance will amend Ordinance 6724, Section 4, to agree with the legal description approved by the Boundary Review Board.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 6724, Section 4 is amended to read as

follows:

That portion of the Northwest 1/4 of the Southwest 1/4 of Section 28, T. 21 N., R 4 E., W.M., King County, Washington, lying Northwesterly of the Southeasterly margin of Primary State Highway No. 1 (AKA SR 5), EXCEPT any portion of the West 30 feet thereof lying within the right-of-way of 16th Avenue South;

TOGETHER WITH the Southwest 1/4 of the Southwest 1/4 of said Section 28 LESS the following described parcel:

The North 1/2 of the Northeast 1/4 of the Southwest 1/4 of the Southwest 1/4 of Section 28, T. 21 N., R. 4 E., W.M., LESS the West 20 feet of the South 20 feet thereof;

ALSO TOGETHER WITH that portion of the Southeast 1/4 of Section 29, T. 21 N., R. 4 E., W.M., King County, Washington, lying Southeasterly of the Northwesterly margin of Primary State Highway No. 1 (AKA SR 5);

ALSO TOGETHER WITH that portion of the North 1/2 of the Northeast 1/4 of Section 32, T. 21 N., R. 4 E., W.M., King County, Washington, lying Easterly of the Westerly margin of Primary State Highway No. 1 (AKA SR 5);

TOGETHER WITH that portion of the right-of-way for South 372nd Street (AKA County Road No. 200) situated in the South 1/2 of the NE 1/4 of said Section 32 and lying Easterly of said Westerly margin of Primary State Highway No. 1 (AKA SR 5). EXCEPT A: That portion lying west of the west right-of-way line of I-5, comprising approximately 4 acres, and EXCEPT B: That portion of the NE 1/4 of the NE 1/4 of Section 32, Township 21 North, Range 4 East, lying southerly and easterly of the east limit access line of SR 5.
