- The various utilities serving the area have been notified and the department of public works was advised that easements are not required.
- 5. The division of building and land development has studied the subject proposed road vacation and finds that it would not be in conflict, with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
