ORDINANCE NO. 7336

1 AN ORDINANCE making an appropriation of \$48,410 to
2 the planning division; and appropriating \$6,949 to
3 the Building and Land Development Fund from the
4 Current Expense Fund Special Programs, Executive
5 Contingency; for the purpose of implementing the
6 Comprehensive Plan; and appropriating \$85,076 to
7 the planning division from Current Expense Fund,
8 Executive Contingency, for the purpose of a Parks
9 and Open Space Plan; and amending Ordinance No. 7027,
10 Sections 18, 23, 39, 60, and 82, as amended.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. There is hereby approved and adopted an
13 appropriation of \$48,410 to the planning division from the Current
14 Expense Fund Special Programs, Executive Contingency for the
15 purpose of implementing the Comprehensive Plan.

16 SECTION 2. Ordinance No. 7027, Section 18, as amended, is
17 hereby amended by adding thereto and inserting therein the
18 following:

19 From the Current Expense Fund there is hereby appropriated to:

20 Planning \$48,410

21 of which \$10,000 is for the purpose of having one
22 additional FTE to begin full time work on the
23 following plan amendment studies starting October 1,
24 1985: Lakeridge, Ralston Purina and Burien Datsun.

25 SECTION 3. There is hereby approved and adopted an
26 appropriation of \$6,949 to the Building and Land Development Fund
27 from the Current Expense Fund Special Programs, Executive
28 Contingency for the purpose of reviewing interim fire protection
29 standards in conjunction with implementation of the Comprehensive
30 Plan.

31 SECTION 4. Ordinance No. 7027, Section 39, as amended, is
32 hereby amended by adding thereto and inserting therein the
33 following:

From the Current Expense Fund there is hereby appropriated to:
