ORDINANCE NO. 7401

AN ORDINANCE extending the Northeast Sammamish Comprehensive Sewer Plan approval until September 30, 1986, amending Ordinance 4489, Section 1, and repealing Ordinance 4489, Section 2.

PREAMBLE:

On September 20, 1979, King County approved Ordinance 4489, granting interim approval of the Sahalee Sewer Comprehensive Plan. Approval was valid for one year after the East Sammamish Community Plan was approved.

On December 22, 1982, King County passed Ordinance 6252, which approved the East Sammamish Community Plan.

On August 20, 1985, the Utilities Technical Review Committee recommended that the sewer plan approval be extended for one year. This would allow Water District 81 and the Northeast Sammamish Sewer and Water District to jointly plan for sewers.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 4489, Section 1 is hereby amended to read as follows:

The Northeast Sammamish Sewer and Water District (formerly the Sahalee Sewer District) Comprehensive Plan, as adopted and amended by District Resolution No. 268 (attached) is hereby granted interim approval only to the extent that the facilities provided for by the comprehensive plan are necessary to provide service to the Local Service Area established by the King County Sewerage General Plan. This approval shall be valid ((for-a-period-not-to-exceed-twelve-months-after-the-adoption of-the-East-Sammamish-Gommunities-Plan-by-the-King-Gounty council;)) until September 30, 1986. ((Upon-adoption-of-the-East-Sammamish-Gommunities-Plan, King-Gounty-through-the Utilities-Technical-Review-Gommittee-shall-initiate-a reexamination-of-the-Sahalee-Sewer-Gomprehensive-Plan-in-light of-the-provisions-of-the-Gommunity-Plan, and the-modified-bocal Service-Area, (if-any), --After-such-reexamination, the

4	expiration of the interim approval, the district shall provide
5	an updated plan pursuant to K.C.C. 13.24 which shall be
