ORDINANCE NO. 7149

AN ORDINANCE relating to the annexation of an area known as 8th Avenue South/South 156th Street to King County Water District No. 49.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as 8th Avenue South/South 156th Street to King County Water District No. 49 was filed with the county council effective October 11, 1985.
- 2. King County Water District No. 49 has found the petition for annexation to be sufficient and has, by Resolution No. 881, concurred with the proposed annexation.
- 3. King County Water District No. 49 filed a Declaration of Non-significant Impact dated July 16, 1985, on the proposed annexation.
- 4. The county council held a public hearing on the 30^{n} day of <u>Occember</u>, 1985 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 49 of the area known as 8th Avenue South/South 156th Street and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on 8th Avenue South/South 156th Street.
