ORDINANCE NO. 7450

AN ORDINANCE relating to the withdrawal of territory known as 8th Avenue South/South 156th Street, from King County Water District No. 20.

STATEMENT OF FACT:

1. A notice of intention proposing the withdrawal of territory known as 8th Avenue South/South 156th Street from King County Water District No. 20 was filed with the county council effective November 18, 1985.

2. King County Water District No. 20 has found the petition for withdrawal to be sufficient and has, by Resolution No. 504 concurred with the proposed withdrawal.

3. King County Water District No. 20 filed a Declaration of Non-significant Impact dated August 25, 1985, on the proposed withdrawal.

4. The county council held a public hearing on the 30th day of December, 1985 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The withdrawal by King County Water District No. 20 of the area known as 8th Avenue South/South 156th Street and described in Section 2 herein is approved. This proposed withdrawal is consistent with R.C.W. 57.02.040 as described in the attached King County Council Withdrawal Report on 8th Avenue South/South 156th Street.

1 SECTION 2. The area known as 8th Avenue South/South 156th
2 Street is described as follows:

3 That portion of the northeast quarter of the
4 southwest quarter of Section 20, Township 23
5 North, Range 4 East, W.M., in King County,
6 Washington, described as follows:

7 Beginning at a point 775.5 feet south and 30.00
8 feet west of the northeast corner of the southwest
9 quarter of said Section 20; thence west, 466.01
10 feet, thence south, 216.30 feet, thence east to
11 the west line of Des Moines Way South (8th Avenue
12 South); thence north along said west line to the
13 beginning; EXCEPT that portion thereof for County
14 road conveyed by deeds recorded under Recording
15 Numbers 6696844 and 89212280811.
