ORDINANCE NO. 7483

AN ORDINANCE repealing Ordinance 6772 and concurring with the recommendation of the Zoning and Subdivision Examiner to approve BC-P subject to conditions upon the application for reclassification petitioned by PETER J. MODDE, designated Building and Land Development File No. 234-83-R, and amending pre-effective condition 1.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 6772 is hereby repealed.

SECTION 2. This ordinance adopts and incorporates the findings and conclusions of the September 6, 1985 report of the zoning and subdivision examiner, filed with the clerk of the council on September 26, 1985, on the application of Peter J. Modde to reclassify certain property described in the building and land development file no. 234-83-R.

SECTION 3. The Council does hereby adopt as its action the recommendation contained in the September 6, 1985, report of the zoning and subdivision examiner, and amends Pre-effective Condition 1 to read as follows:
