ORDINANCE NO. 7520

AN ORDINANCE relating to the annexation of an area known as 85-1 to Southwest Suburban Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as 85-1 to Southwest Suburban Sewer District was filed with the county council effective December 30, 1985.
- 2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 85-46 concurred with the proposed annexation.
- 3. Southwest Suburban Sewer District filed a Declaration of Non-significant Impact dated October 15, 1985, on the proposed annexation.
- 4. The county council held a public hearing on the 274 day of 1986 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Southwest Suburban Sewer

District of the area known as 85-1 and described in Section 4

SECTION 2. The Southwest Suburban Sewer District is the appropriate entity to serve the area proposed to be annexed.

Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.
