AN ORDINANCE making an appropriation of \$11,230,400 to CIP Project No. 038000, Woodland Park Zoo Project in Fund 311, Zoo Development Fund, from bond proceeds for the purpose of providing funds to the City of Seattle to acquire, construct, equip and make certain capital improvements to the Woodland Park Zoo, amending Ordinance No. 7422, Section 78, Attachment No. 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The county council finds that the City of Seattle has completed all actions required by King County Ordinance 7616, Section 16, for the release of bond proceeds for the purpose of providing funds to the City of Seattle to acquire, construct, equip and make certain capital improvements to the Woodland Park Zoo for Phase I projects and Phase II projects planned for 1987.

SECTION 2.

- A. The county council approves the City's Project Management Plan for implementation of the Zoo Project as reasonable and consistent with Exhibit A of King County Ordinance 7666, as required by King County Ordinance 7616, Section 16.B.1.b.
- B. The county council approves the City's Capital Improvement Program Plan for Phase I projects and 1987 Phase II projects as being consistent with the Zoo Project as required by King County Ordinance 7616, Section 16.B.2.b.
- SECTION 3. There is hereby approved and adopted an appropriation of \$11,230,400 to CIP Project No. 038000 Woodland Park Zoo Project in Fund 311, Zoo Development Fund, from bond proceeds for the purpose of providing funds to the City of Seattle to acquire, construct, equip and make certain capital improvements to the Woodland Park Zoo.
