ORDINANCE NO. 7751

An ordinance relating to traffic control, prohibiting parking at all times on: the south side of Southeast 316th Place between 118th Place Southeast and 119th Place Southeast; the west side of 119th Place Southeast between Southeast 316th Place and Southeast 317th Place; the north side of Southeast 317th Place between 118th Place Southeast and 119th Place Southeast; the east side of 118th Place Southeast between Southeast 318th Place and Southeast 319th Place; the north side of Southeast 319th Place between 118th Place Southeast and 120th Avenue Southeast; the west side of 120th Avenue Southeast between Southeast 318th Place and Southeast 319th Place, and amending King County Ordinance 5292, Schedule 14.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1: Pursuant to traffic engineering studies, and as authorized by RCW 46.90, Schedule 14 of King County Ordinance 5292 which prohibits parking at all times along county roads, is amended to add the following locations:

SOUTHEAST 316TH PLACE, on the south side, between 118th Place Southeast and 119th Place Southeast.

119TH PLACE SOUTHEAST, on the west side, between Southeast 316th Place and Southeast 317th Place.

SOUTHEAST 317th PLACE, on the north side, between 118th Place Southeast and 119th Place Southeast.

118TH PLACE SOUTHEAST, on the east side, between Southeast 318th Place and Southeast 319th Place.

SOUTHEAST 319TH PLACE, on the north side, between 118th Place Southeast and 120th Avenue Southeast.

120TH AVENUE SOUTHEAST, on the west side, between Southeast 318th Place and Southeast 318th Place and Southeast 319th Place.

SECTION 2: Signs posted to evidence the above described restriction shall ,
be installed by the proper authority.
