ORDINANCE NO.

7755

AN ORDINANCE establishing the date of an election on the question of annexation of certain contiguous unincorporated territory to the City of Lake Forest Park and declaring an emergency.

STATEMENT OF FACT:

- The City Council of the City of Lake Forest Park. Washington, by Resolution No. 224 has determined that the public interest, health, safety and general welfare of the City of Lake Forest Park would be served by the annexation of certain contiguous unincorporated territory as hereby described in accordance with R.C.W. 35.15.015.
- Said ordinance does satisfy the provisions of 35.13 R.C.W. for qualification for annexation by election.
- The Boundary Review Board for King County, Washington, has considered the proposed annexation, and having chosen not to invoke jurisdiction, deems the annexation approved by report dated August 8, 1986.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A special election shall be held on the 4th day of November, 1986, as provided by law, in accordance with R.C.W. 35.13.070 within the territory of the proposed annexation as herein described, for the purpose of submitting to the qualified electors within said territory, the question of annexation to the City of Lake Forest Park.

SECTION 2. The boundaries of the territory proposed for annexation are hereby described as follows:

All that portion of Section 4 and Section 9, Township 26 North, Range 4 East, W.M., described as follows:

COMMENCING at the northeast corner of Tract 13 Trafford Park Tracts Unrecorded, said point being north $41^{\circ}02'$ west 380 feet from the northwest corner of the intersection of 26th Avenue N.E. with N.E. 185th Street; thence south 41002' east along the southwesterly margin of 26th Avenue N.E. 23.24 feet;

thence west along said south margin of NE 185th Street to its intersection with the southerly extension of the east line of the west 290 feet of Tract 5, Block 2 of Northside Five Acre Tracts as recorded in Volume 15 of Plats, Page 73 records of said county;

thence north along said extension to the north margin of NE 185th Street;

thence continuing north along the east line of the west 290 feet of said Tract 5, a distance of 140 feet to the city limits of Lake Forest Park as established by Ordinance No. 153;

thence north 88043'56" west 80 feet;

thence north 1038' west 161.5 feet to the north line of Lot 5, Block 2 of Northside Five Acre Tracts as recorded in Volume 15 of Plats, Page 73, records of King County, Washington;

thence west along the north line of said Lot 5 and continuing west along the north line of Lot 4, Block 2 of said Northside Five Acre Tracts to a point 390 feet west of the northeast corner of said Lot 4;

thence south to the north margin of NE 185th Street;

thence west to the west margin of 30th Avenue NE;

thence north along the west margin of 30th Avenue NE to the northeast corner of Plat of Hazel's Glen as recorded in Volume 49 of Plats, Page 69, records of King County, Washington;

thence west along the north line of said Plat of Hazel's Glen and continuing along the north line of Lael Addition as recorded in Volume 52 of Plats, Page 100, records of King County, Washington, to the northwest corner of said Lael Addition;

thence south along the west line of said Lael Addition and its southerly extension 629.31 feet to the north margin of NE 185th Street; thence westerly along said north margin 500 feet more or less to the TRUE POINT OF BEGINNING. SECTION 3. The notice of election shall be published as required by law. SECTION 4. The county council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health or safety or for the support of county government and its existing public institutions.
