AN ORDINANCE amending Ordinance No. 7489 granting preliminary approval to the planned unit development of West Campus 112, designated (BALD File No. 228-85-P), with amended findings, conclusions and conditions modified.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 7489, is hereby amended as follows:

This ordinance does hereby adopt and incorporate herein Findings Nos. 1-9 and conclusions Nos. 1, 3, 4, 5, and 6 as contained in the report of the zoning and subdivision examined dated November 6, 1985, and the council does hereby approve the proposed planned unit development of WEST CAMPUS 112, designated File No. 228-85-P, with the following amendments:

Conclusion 2 of the examiner's report and recommendation of November 6, 1985, is amended as follows:

2. It is concluded that a substantial hazard currently exists at the intersection of First Avenue South and S.W. 325th ((Street)) Place. Cars "stacking up" to wait for left turns into the Quiet Forest Condominium create a dangerous condition which could be worsened by added traffic from this and future projects. Thus, in order to protect the public safety, ((ne cecupancy of units in West Campus 112 should occur until a left turn-lane-and-signalization-are-provided-on-First-Avenue-South.)) traffic signals shall be installed at the intersection of S.W.

325th Place and First Avenue South. The developer for the planned unit development of West Campus 112 will be required pay their fair share of the cost of installation of signals at the intersection of S.W. 325th Place and First Avenue South.

Insofar as the level of service at the intersection of

First Avenue South with S.W. 320th Street could be improved by

providing left turn signalization for the First Avenue South
