ORDINANCE NO. 7799

AN ORDINANCE relating to the annexation of an area known as DS 86-8 to Des Moines Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS 86-8 to Des Moines Sewer District was filed with the county council effective August 3, 1986.

2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1986-33 concurred with the proposed annexation.

3. Des Moines Sewer District filed a Declaration of Non-significant Impact dated July 23, 1986, on the proposed annexation.

4. The county council held a public hearing on the 29<sup>th</sup> day of September, 1986 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Des Moines Sewer District of the area known as DS 86-8 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on DS 86-8.

SECTION 2. The Des Moines Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

1        SECTION 4. The area known as DS 86-8 to be annexed is  
2 described as follows:

4        That portion of the South 1/2 of the SW 1/4 of Section 9,  
Township 22 North, Range 4 East, W.M., described as follows:

5        Beginning at the intersection of the South line of the said SW  
6 1/4 with the West line of the East 180 feet thereof;

7        Thence Northerly along said West line to its intersection with  
the centerline of South 223rd Street;

8        Thence Westerly along said centerline to its intersection with  
9 the East line of the West 708.75 feet of the SE 1/4 of the  
said SW 1/4;

10       Thence Northerly along said East line to its intersection with  
11 the centerline of South 22nd Street;

12       Thence Easterly along said centerline to its intersection with  
the West line of the East 180 feet of the said SW 1/4;

13       Thence Northerly along said West line to its intersection with  
14 North line of the South 1/2 of the said SW 1/4;

15       Thence Westerly along said North line to its intersection with  
the centerline of 19th Avenue South;

16       Thence Southerly along said centerline to its intersection  
17 with the centerline of South 222nd Street;

18       Thence Westerly along said centerline to its intersection with  
the centerline of 18th Place South;

19       Thence Southerly along said centerline to its intersection  
20 with the centerline of South 223rd Street;

21       Thence Southerly 42 feet more or less to the intersection of  
22 the Southerly margin of South 223rd Street with the centerline  
of 19th Avenue South;

23       Thence Southerly along said centerline to its intersection  
24 with the South line of the said SW 1/4;

1 Thence Easterly along said south line to its intersection with  
2 the West line of the East 180 feet of the said SW 1/4 and the  
3 Point of Beginning.
