ORDINANCE NO. 7847

AN ORDINANCE concurring with the recommendation of the Zoning and Subdivision Examiner, amending King County Zoning Resolution No. 25789, as amended, by denying in part and reclassifying in part certain property upon the application of ROBERT COLLOP, designated Building and Land Development File No. 225-86-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinances adopts and incorporates the findings and conclusions of the October 3, 1986 report of the zoning and subdivision examiner, filed with the clerk of the council on October 30, 1986 on the application of Robert Collop to reclassify certain property described in building and land development file no. 225-86-R.

SECTION 2. The recommendation of the zoning and subdivision examiner to deny that portion of the property identified as future commercial development on exhibit 9 and reclassify the remainder of the subject property from BC to C-G-P subject to conditions (modified) is hereby adopted by the council of King County.
