ORDINANCE NO. 7899 AN ORDINANCE relating to the annexation of an area known as Eastside to King County

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Eastside to King County Water District No. 54 was filed with the county council effective December 10, 1986.
- 2. King County Water District No. 54 has found the petition for annexation to be sufficient and has, by Resolution No. 1985-4 concurred with the proposed annexation.
- 3. King County Water District No. 54 filed a Declaration of Non-significant Impact dated November 18, 1986, on the proposed annexation.
- The county council held a public hearing on the 542 day 4. and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 54 of the area known as Eastside and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Eastside.

SECTION 2. King County Water District No. 54 is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.
