ORDINANCE NO.

AN ORDINANCE related to the merger of King County Water District No. 58 into Cascade Sewer District, calling for an election, and changing the name of the merged sewer district to "Soos Creek Water and Sewer District."

STATEMENT OF FACT:

- 1. A notice of intention proposing the merger of King County Water District No. 58 into Cascade Sewer District was filed with the county council effective November 19, 1986.
- 2. King County Water District No. 58 has by Resolution No. 2626, as amended by Resolution No. 2664, determined that the merger of the water district into Cascade Sewer District shall be condusive to the public health, welfare and convenience, and be of special benefits to the lands within the water district, pursuant to R.C.W. 56.36.030.
- 3. Cascade Sewer District has by Resolution No. 2398 as amended by Resolution No. 2433, determined that the merger of King County Water District No. 58 into the sewer district shall be conducive to the public health, welfare, and convenience, and be of special benefits to the lands within the sewer district.
- 4. King County Water District No. 58 and Cascade Sewer District have both approved the merger agreement dated August 21, 1986.
- 5. The county council, having verified that King County Water District No. 58 is in proximity to Cascade Sewer District as defined by R.C.W. 56.36.010, held a public hearing on the 17th day of 26 may, 1987 and has considered the criteria set forth in R.C.W. 56.02.60.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The merger of King County Water District No. 58 into Cascade Sewer District, described in the legal description as provided in Attachment A, appended hereto and made a part of this ordinance, is approved subject to a special election to be held among the registered voters of King County Water District No. 58. The proposed merger is consistent with R.C.W. 56.02.060.

SECTION 2. A special election shall be held on April 7, 1987, in accordance with the general election laws.

SECTION 3. The Boundary Review Board for King County did not receive any request for review and did not choose to envoke jurisdiction, and the sixty day period subsequent to filing having

elapsed, said board approved the merger as of January 13, 1987. ı SECTION 4. Completion of this merger does not constitute 7 county approval or disapproval of any other permits, franchises, 3 certifications, or actions necessary to provide service to this merged area, nor does it authorize sewer service in any area not designated as a "local service area" by the King County Sewerage General Plan. Changes to the boundaries of the district's sewer and water service areas, as described in the districts' respective approved 9 sewer and water comprehensive plans, whether within or without thel 10 boundaries of the merged district, shall be in accordance with 11 K.C.C. 13.24. 12 SECTION 5. Provided that the merger is ratified by special 13 election, the county council further approves the change in name 14 of the resultant merged district from "Cascade Sewer District" to 15 "Soos Creek Water and Sewer District", pursuant to R.C.W. 16 56.08.015.
