AN ORDINANCE relating to the annexation of an area known as P-270RR to Cascade Sewer District.

## STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as P-270RR to Cascade Sewer District was filed with the county council effective February 18, 1987.
- 2. Cascade Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 2445 concurred with the proposed annexation.
- 3. Cascade Sewer District filed a Declaration of Non-significant Impact dated January 12, 1987, on the proposed annexation.
- 4. The county council held a public hearing on the 23 day of 23 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Cascade Sewer District of the area known as P-270RR and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on P-270RR.

SECTION 2. The Cascade Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. Approval of this request shall not be construed as authorizing the extension of sewer service outside the adopted Sewer Local Service Area as designated by the Soos Creek Plateau Communities Plan.

Sewer service within the area currently designated as rural in the Soos Creek Plateau Communities Plan shall be authorized only after the location of rural land uses have been determined and the local service area of the Soos Creek Plateau Communities Plan has been modified through the Community Plan Update process.

SECTION 5.
