ORDINANCE NO. 8087

AN ORDINANCE relating to the annexation of an area known as Shadowbrook to Woodinville Water District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Shadowbrook to Woodinville Water District was filed with the county council effective October 11, 1985.

2. Woodinville Water District has found the petition for annexation to be sufficient and has, by Resolution No. 1927 concurred with the proposed annexation.

3. Woodinville Water District filed a Declaration of Non-significant Impact dated September 17, 1985, on the proposed annexation.

4. The Boundary Review Board has approved the annexation subject to preliminary plat approval which was authorized by the King County Council on April 27, 1987

5. The county council held a public hearing on the 26th day of May, 1987 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Woodinville Water District of the area known as Shadowbrook and described in Section 4 herein is approved for water service. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Shadowbrook.

SECTION 2. Woodinville Water District is the appropriate entity to serve the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not constitute
2 county approval or disapproval of any other permits, certifica-
3 tions, or actions necessary to provide service to this annexation
4 area.

5 SECTION 4. The area known as Shadowbrook to be annexed is
6 described as follows:

7 Those portions of Sections 19, 20, 29, and 30, Township
8 26 North, Range 6 East, W.M., in King County,
Washington, described as follows:

9 That portion of the Southeast quarter of the Southeast
10 quarter of said Section 19 lying South of the South
margin of N.E. 133rd Street and Southeast of the South
margin of Bear Creek Road N.E.

11 AND ALSO that portion of the Southwest quarter of said
12 Section 20 lying South of the South margin of N.E. 133rd
Street.

13 AND ALSO that portion of the Northeast quarter of said
14 Section 30 lying East of the west margin of Avondale
Road N.E.

15 AND ALSO the Northwest quarter of said Section 29.
16 AND ALSO the Southeast quarter of the Northwest quarter
of said Section 30.

17 INTRODUCED AND READ for the first time this 4th day
18 of May, 1987.
