ATTACHMENT A

SEATTLE SYMPHONY ORCHESTRA RECOMMENDED SCOPE OF SERVICES

The Seattle Symphony Orchestra (SSO) and the King County Arts Commission (KCAC) mutually agree the following services will be provided:

- 1. King County agrees to purchase artistic services and to pay artistic fees for programs during 1987.
- The SSO agrees to give the KCAC continual program credit 2. for chamber and full symphony concerts, runout performances and educational programs for all Seattle and King County services during the 1987/1988 Season.
- 3. The SSO agrees to provide the KCAC with a final report to include:
 - List of programs, location and attendance; actual budget for listed programs; a)

b)

- schedule for future performances in King County outside the City of Seattle for the 1987/1988 Season; c) and
- d) a detailed description of criteria for serving on the Board of Directors; a description of the recruitment process for new board members and a list of organizations contacted to solicit minority board participation.
- The SSO will take the steps necessary to meet existing initial eligibility requirements for the National Arts Stabilization Fund (NASF) program. 4.
- By July, 1990, the SSO will seek nomination to and participate in the NASF program, unless, within that time, a more effective approach to achieve and maintain 5. SSO fiscal discipline and stability is pursued, considering the advice of the King County Arts Commission.
- The SSO agrees not to apply for any portion of the \$100,000 allocated for arts stabilization by King County in 1987. Any future years' special funds by King County 6. to the SSO over and above the regional allocation shall be channeled through the mechanism established by the King County Council.
- The SSO agrees to develop, in conjunction with the King County Arts Commission, a plan for publicizing and marketing the program or services provided herein, to assure maximum utilization of these services by King County citizens. The SSO further agrees to cooperate with the County in targeting any special populations or groups identified by the County.
- All publicity and promotional materials including, but 8. not limited to, brochures, press releases, programs, posters, public service announcements, flyers and advertisements, shall credit the King County Arts Commission for its support of this project
