ORDINANCE NO.8162

AN ORDINANCE relating to the annexation of an area known as Valley View Mobile Home Park to Cedar River Water and Sewer District.

## STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Valley View Mobile Home Park to Cedar River Water and Sewer District was filed with the county council effective June 23, 1987.
- 2. Cedar River Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 2387 concurred with the proposed annexation.
- 3. Cedar River Water and Sewer District filed a Declaration of Non-significant Impact dated April 24, 1987, on the proposed annexation.
- 4. The county council held a public hearing on the 20% day of \_\_\_\_\_\_\_\_, 1987\_\_\_\_\_\_ and has considered the criteria set forth in R.C.W. 57.02.040 and RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cedar River Water and Sewer District of the area known as Valley View Mobile Home Park and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 and R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on Valley View Mobile Home Park.

SECTION 2. Cedar River Water and Sewer District is the appropriate entity to serve the area proposed to be annexed.
