

ORDINANCE NO. 8179

AN ORDINANCE assigning the administration of the sheriff's civil service system to the personnel division of the department of executive administration; repealing Ordinance 3390 as amended and K.C.C 3.14.010; and repealing Ordinance 7558 and K.C.C. 3.14.020.

PREAMBLE:

Under chapter 251, Laws of 1987, King County is authorized to assign certain statutory powers and duties of the sheriff's civil service commission to other county agencies or departments. Similarly, Section 970.50 of the King County Charter authorized assignment of these duties to the general county personnel system. The county council finds that such an assignment would promote efficiency in the administration of the sheriff's personnel system.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

NEW SECTION. SECTION 1. The powers and duties of the sheriff's civil service commission under Chapter 41.14 RCW are hereby assigned to the personnel division of the department of executive administration except those powers and duties set forth in RCW 41.14.120.

NEW SECTION. SECTION 2. The sheriff's civil service commission shall continue to hear and decide cases regarding removals, suspensions, and demotions as provided in RCW 41.14.120.

NEW SECTION. SECTION 3. The position of secretary/chief examiner of the sheriff's civil service commission is hereby abolished as of the effective date of this Ordinance. Any functions which have heretofore been performed by said secretary/chief examiner are hereby assigned to the manager of the personnel division.

NEW SECTION. SECTION 4. Rules and regulations for the administration of the sheriff's personnel system shall be adopted and amended by the county council by ordinance. The manager of

1 the personnel division is directed to promulgate administrative
2 guidelines for the purpose of implementing such rules and
3 regulations and the requirements of Chapter 41.14 RCW.

4 NEW SECTION. SECTION 5. Except to the extent they are
5 inconsistent with the provisions of this Ordinance, the current
6 rules and regulations of the sheriff's civil service commission,
7 which are attached hereto, are hereby incorporated by this
8 reference and made a part hereof and adopted for the
9 administration of the sheriff's personnel system. The county
10 executive shall review such rules and regulations and report by
11 July 1, 1988 to the county council proposing such amendments
12 thereto as may be appropriate to bring such rules into
13 substantial conformance with general county personnel rules
14 insofar as permitted by Chapter 41.14 RCW.

15 SECTION 6. Ordinance 3390, as amended, and K.C.C. 3.14.010
16 are hereby repealed.

17 SECTION 7. Ordinance 7558 and K.C.C. 3.14.020 are hereby
18 repealed.

19 SECTION 8. This Ordinance shall take effect no earlier than
20 July 27, 1987.

1 SECTION 9. Should any section, subsection, paragraph,
2 sentence, clause or phrase of this Ordinance be declared
3 unconstitutional or invalid for any reason, such decision shall
4 not affect the validity of the remaining portion of this
5 Ordinance.

RE: Abolition of Secretary/Chief Examiner Position

Dear Mr. Davis:

On August 10, 1987, the King County Council adopted Ordinance No. 8179 regarding the organization and functions of the Sheriff's Civil Service Commission. I have approved that Ordinance today which will make it effective on August 25, 1987, and have enclosed a copy of this new law for your information.

Under Section 3 of the new Ordinance, as a part of the process of transferring administration of the Sheriff's Civil Service System to the County Personnel Division consistent with Chapter 251, Washington Laws of 1987, the position you presently occupy as Secretary/Chief Examiner is abolished as of the effective date of this Ordinance. Inasmuch as I am advised by the Personnel Division that there are currently no positions available to which you would be entitled under Section 11.2 of the Civil Service Rules, the result is that your employment with King County will end as of the effective date of this Ordinance; namely, August 25, 1987.
