ORDINANCE NO. 8186

AN ORDINANCE relating to the annexation of an area known as Hjelte to Woodinville Water District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Hjelte to Woodinville Water District was filed with the county council effective July 17, 1987.
- 2. Woodinville Water District has found the petition for annexation to be sufficient and has, by Resolution No. 2227 concurred with the proposed annexation.
- 3. Woodinville Water District filed a Declaration of Non-significant Impact dated May 27, 1987, on the proposed annexation.
- 4. The county council held a public hearing on the $\underline{/0\%}$ day of $\underline{000}$, 1987 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
