ORDINANCE NO. 3186

AN ORDINANCE relating to the annexation of an area known as Hjelte to Woodinville Water District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Hjelte to Woodinville Water District was filed with the county council effective July 17, 1987.

2. Woodinville Water District has found the petition for annexation to be sufficient and has, by Resolution No. 2227 concurred with the proposed annexation.

3. Woodinville Water District filed a Declaration of Non-significant Impact dated May 27, 1987, on the proposed annexation.

4. The county council held a public hearing on the 10th day of August, 1987 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Woodinville Water District of the area known as Hjelte and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Hjelte.

SECTION 2. Woodinville Water District is the appropriate entity to serve the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not constitute
2 county approval or disapproval of any other permits, certifica-
3 tions, or actions necessary to provide service to this annexation
4 area.

5 SECTION 4. The area known as Hjelte to be annexed is
6 described as follows:

7 The Northwest quarter of Section 22, Township 26 North, Range
8 6 East, Willamette Meridian, King County, Washington.

9 Except that portion thereof lying within the North 1/2 of the
10 North 1/2 of the Northwest 1/4 of the Northwest 1/4 of SAID
11 Section 22.

12 Also except the Southwest quarter thereof.

13 Together with the Northeast quarter of the Southwest quarter
14 of said Section 22.

15 Also together with Lots 1 through 3 inclusive, King County
16 Short Plat No. 280071 as recorded under Recording No.
17 8206070454, being a portion of the Southwest quarter of the
18 Northeast quarter of said Section 22.

19 Also together with Lot C, King County Short Plat No. 576030 as
20 recorded under Recording No. 7612290705.
