ORDINANCE NO. 8267

AN ORDINANCE making a supplemental appropriation of \$417,743 to the department of adult detention from unappropriated Current Expense fund balance to support additional staffing required to address the most critical areas of the jail affected by higher than anticipated average daily population levels and \$105,168 to the Property Room Remodel and \$6,050 to the Court Detail Holding Cell Remodel, in the Jail Renovation and Construction Fund, from unallocated Current Expense Fund balance, and amending Ordinance No. 7864, Sections 40 and 74, Attachments 1 and 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$417,743 to the department of adult detention from unappropriated Current Expense Fund balance to support additional staffing, overtime, and supplies required to address the most critical areas of the jail affected by higher than anticipated average daily population levels.

SECTION 2. There is hereby approved and adopted a supplemental appropriation of \$105,168 to CIP Project No. 002042, Property Room Remodel, and \$6,050 to CIP Project No. 002043, Court Detail Holding Cell Remodel, in the Jail Renovation and Construction Fund from unappropriated Current Expense Fund balance.

SECTION 3. Ordinance No. 7864, Section 40, as amended, is hereby amended by adding thereto and inserting therein the following:

ADULT DETENTION - from the Current Expense Fund there is hereby appropriated to:


