ORDINANCE NO. 18273

AN ORDINANCE appropriating \$976,283 from various revenue sources described herein, in the Parks, Recreation, and Open Space Fund; including \$301,587 to the Sammamish River Trail CIP Project #007124, \$291,000 to the Lisabuela Park CIP Project #070313, \$198,600 to the Missing Link Trail CIP Project #007150, \$40,000 to the King County Fairgrounds CIP Project #007087, \$106,500 to the Big Finn Hill Park CIP Project #040045, \$38,596 to Palisades Park CIP Project #010102, and \$187,500 to the Transfer to Fund 316 CIP Project #010103 In the Parks Acquisition and Development Fund from unappropriated fund balance, amending Ordinance No. 7864, Section 75, Attachments No. 1 and No. 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$301,587 to the Sammamish River Trail CIP Project No. 007124 in the Parks, Recreation and Open Space Fund from unappropriated fund balance in the same fund, for land acquisition purposes.

SECTION 2. There is hereby approved and adopted an appropriation of \$291,000 to the Lisabuela Park CIP Project No. 070313 in the Parks, Recreation and Open Space Fund from unappropriated fund balance in the same fund to be reimbursed by IAC grant funds, and from a transfer of funds from CIP Project No. 026006, Emergency Contingency - Fund 316, for land acquisition purposes.

SECTION 3. There is hereby approved and adopted an appropriation of \$198,600 to the Missing Link Trail CIP Project No. 007150 in the Parks, Recreation and Open Space Fund from unappropriated fund balance in the same fund totaling \$117,560 to be reimbursed by IAC grant funds, and from unappropriated fund balance totaling \$81,000 in Fund 337, the Parks Acquisition and Development Fund, for land acquisition purposes

SECTION 4. There is hereby approved and adopted an appropriation of \$40,000 to the King County Fairgrounds CIP Project No. 007087 in the Parks, Recreation and Open Space fund from unappropriated fund balance in the same fund to be reimbursed by state grant funds, for facility rehabilitation purposes.

SECTION 5. There is hereby approved and adopted an appropriation of \$106,500 to the Big Finn Hill CIP Project No. 040045 in the Parks, Recreation and Open Space Fund, from unappropriated fund balance in Fund 337, the Parks Acquisition and Development Fund, for park development purposes.

SECTION 6. There is hereby approved and adopted an appropriation of \$38,596 to the Palisades Park CIP Project No. 010102 in the Parks, Recreation and Open Space Fund, from unappropriated fund balance in the same fund for park development purposes.

SECTION 7. There is hereby approved and adopted an appropriation of \$187,500 to the Transfer to Fund 316 CIP Project No. 010103 from unappropriated fund balance in Fund 337, the Parks Acquisition and Development Fund, to transfer to Fund 316 for park development purposes identified in this ordinance.

SECTION 8. Ordinance No. 7864, Section 75, Attachments No. 1 and No. 2, as amended, are hereby amended by adding thereto and inserting therein the following:

From the several capital improvement program funds, there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment No. 1 as adjusted by Attachment No. 2 of this ordinance.
