ORDINANCE NO. 18274

AN ORDINANCE appropriating \$81,361 to the Solid Waste Construction 1987 Fund; \$4,993 to the Courthouse Complex Construction 1987 Fund; \$806 to the Police Field Facilities Construction 1987 Fund; and \$7,898 to the Parks Construction 1987 Fund; from bond proceeds for payment of financial advisory services and bond counsel for the 1987 various purpose limited G.O. bond issue; and amending Ordinance No. 7864, Section 75, as amended.

SECTION 1. There is hereby approved and adopted an appropriation of \$81,361 to CIP Project No. D10729 in the Solid Waste Construction 1987 Fund from bond proceeds for payment of financial advisory services and bond counsel for the 1987 various purpose G.O. bond issue.

SECTION 2. There is here by approved and adopted an appropriation of \$4,993 to CIP Project No. D10456 in the Courthouse Complex Construction 1987 Fund from bond proceeds for payment of financial advisory services and bond counsel for the 1987 various purpose limited G.O. bond issue.

SECTION 3. There is hereby approved and adopted an appropriation of \$806 to CIP Project No. D10209 in the Police Field Facilities Construction 1987 Fund for payment of financial advisory services and bond counsel for the 1987 various purpose limited G.O. bond issue.

SECTION 4. There is hereby approved and adopted an appropriation of \$7,898 to CIP Project No. D10348 in the Parks Construction 1987 Fund from bond proceeds for payment of financial advisory services and bond counsel for the 1987 various purpose limited G.O. bond issue.

SECTION 5. Ordinance No. 7864, Section 75, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment 1 of this ordinance.




