AN ORDINANCE modifying the recommendation of the Zoning and Subdivision Examiner, amending King County Zoning Resolution No. 25789, as amended, by reclassifying certain property upon the application of PETER HANADA, et al., designated Building and Land Development File No. 219-87-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinance adopts and incorporates the findings and conclusions of the July 8, 1987 report of the zoning and subdivision examiner, filed with the clerk of the council on July 23, 1987 on the application of Peter Hanada, et al., to reclassify certain property described in building and land development file no. 219-87-R.

SECTION 2. The recommendation of the zoning and subdivision examiner to reclassify the subject property from SR (potential MH) to MH-P subject to conditions (modified) is hereby adopted by the council of King County, except that condition no. 3 is modified to provide as follows:

3. A site plan which is in conformance with KCC 21.46.150-200, providing for development of the subject property for parking, shall be approved by the building and land development division for each parcel prior to issuance of building or grading permits for each parcel. Any use of the subject property for purposes other than parking shall require submission and approval of a site plan.

Those conditions which must be satisfied before this ordinance becomes effective must be satisfied on or before December 31, 1988, or all authority
