ordinance no. 8305

AN ORDINANCE relating to the annexation of an area known as P-302 to Soos Creek Water and Sewer District, for sewer service only.

STATEMENT OF FACT:

- l. A notice of intention proposing the annexation of an area known as P-302 to Soos Creek Water and Sewer District was filed with the county council effective October 12, 1987.
- 2. Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0037-S concurred with the proposed annexation.
- 3. Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated September 6, 1987, on the proposed annexation.
- 4. The county council held a public hearing on the $\frac{911}{100}$ day of $\frac{November}{100}$, 19 $\frac{87}{100}$ and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District of the area known as P-302 and described in Section 4 herein is approved for sewer service only. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on P-302.

<u>SECTION 2</u>. The Soos Creek Water and Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as P-302 to be annexed is described

Beginning at the Northwest corner of the Southeast quarter of the Northeast quarter of Section 21, Township 22 North, Range 6 East, W.M., in King County, Washington, said point being on the existing boundary of Cascade Sewer District;

Thence Easterly along the South line of the North half of the North half of said Section 21 to the West line of Section 22,

Thence continue Easterly along the South line of the North half of the North half of said Section 22 to the centerline of Primary State Highway No. 5 (Maple Valley-Blacke Diamond Road

Thence Southeasterly along said centerline to the centerline of S.E. 244th Street (George J. Drummer Road Relocation No. 6);

Thence Northeasterly and Easterly along the centerline of said S.E. 244th Street to the Westerly margin line of the City of Seattle Cedar River Pipeline right-of-way;

Thence Southerly and Southeasterly along said right-of-way margin line to the intersection with the East line of said

Thence Southerly along said East line of Section 22 and the east line of Sections 27 and 34, Township 22 North, Range 6 East, W.M., to an intersection with the South line of the North 844.80 feet, more or less, of the Northeast quarter of the Northeast quarter of said Section 34;

Thence Westerly along said South line to the centerline of Primary State Highway No. 5 (Maple Valley-Black Diamond Road No. 1055, or S.R. 169);

Thence Northerly along said centerline to the North line of said section 34, also being the South line of said Section 27;

Thence Westerly along said North line, and the North line of Section 33, Township 22 North, Range 6 East, W.M., to the centerline of Witte Road S.E.;

Thence Northerly along said centerline to its intersection with the centerline of County Road as shown on the plat of Lake Wilderness Five-Acre Tracts, as recorded in Volume 20, page 27 of Plats, at the Northwest corner of Lot 19 of said Plat of Lake Wilderness Five-Acre tracts;

Thence North 25°02'00" East, 325 feet along the centerline of said County Road;

Thence North 36°39'30" East, 239.50 feet along the centerline of said County Road;

Thence North 17°33'00" West 188.60 feet along the centerline of said County Road;

Thence 60°59'00" East 242.56 feet along the centerline of said County Road;
