ORDINANCE NO. 8317

AN ORDINANCE relating to the annexation of an area known as Himmelspach to Woodinville Water District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Himmelspach to Woodinville Water District was filed with the county council effective October 16, 1987.

2. Woodinville Water District has found the petition for annexation to be sufficient and has, by Resolution No. 2275 concurred with the proposed annexation.

3. Woodinville Water District filed a Declaration of Non-significant Impact dated September 24, 1987, on the proposed annexation.

4. The county council held a public hearing on the 16th day of November, 1987 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Woodinville Water District of the area known as Himmelspach and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Himmelspach.

SECTION 2. Woodinville Water District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

1            SECTION 4. The area known as Himmelspach to be annexed is  
2 described as follows:

3            Those portions of Section 19 and Section 30, Township 26  
4 North, Range 6 East, Willamette Meridian, being more  
5 particularly described as follows:

6            That portion of the North half of the Southeast quarter lying  
7 Easterly of the Easterly margin of Avondale Road;

8            That portion of the Southwest quarter of the Southeast quarter  
9 and that portion of the Northeast quarter of Section 30, said  
10 Township and Range, lying Easterly of the Westerly margin of  
11 Avondale Road and Northerly of the Southerly margin of N.E.  
12 132nd Street;

13            That portion of the Southeast quarter of the Southeast quarter  
14 lying Northerly of the Southerly margins of Bear Creek Road  
15 and N.E. 133rd Street.

16            Together with those portions of Section 20, Township 26 North,  
17 Range 6 East. Willamette Meridian, being more particularly  
18 described as follows:

19            That portion of the West half of the Southwest quarter lying  
20 Northerly of the Southerly margin of N.E. 133rd Street.

21            That portion of the Southeast quarter of the Southwest lying  
22 Northerly of the Southerly margin of N.E. 133rd Street.

23            All the above situated in King County, Washington.
