ORDINANCE NO. 8378

AN ORDINANCE relating to the annexation of an area known as 81-69-31R to Southwest Suburban Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 81-69-31R to Southwest Suburban Sewer District was filed with the county council effective December 16, 1987

2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 87-38 concurred with the proposed annexation.

3. Southwest Suburban Sewer District filed a Declaration of Non-significant Impact dated October 20, 1987 on the proposed annexation.

4. The county council held a public hearing on the 11th day of January, 19 88 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Southwest Suburban Sewer District of the area known as 81-69-31R and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 81-69-31R.

SECTION 2. The Southwest Suburban Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as 81-69-31R to be annexed is described as follows:

Beginning at the Southeast corner of the Southwest 1/4 of the Northeast 1/4 of Section 30, Township 23 North, Range 4 East, W.M.,

Thence northerly along the east line of the said Southwest 1/4 to its intersection with the north line thereof;

Thence westerly along said north line to its intersection with the centerline of Sylvester Road;

Thence southwesterly along said centerline to its intersection with the south line of the Northwest 1/4 of said Section 30;

Thence easterly along said south line and the south line of the Northeast 1/4 of said Section 30 to the southeast corner of the Southwest 1/4 of the said Northeast 1/4 of the point of beginning.
