ORDINANCE NO. 18389

AN ORDINANCE relating to the Washington State Boundary Review Board for King County.

PREAMBLE:

In accordance with the provision of Chapter 477 Laws of 1987 which allows the county to file a request for review by the Washington State Boundary Review Board for King County.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Either the King County council by motion or the King County executive or his designee by written request may file a request with the Washington State Boundary Review Board for King County for review of the following actions:

- The: 1. Creation, incorporation, or change in the boundary, other than a consolidation, of any city, town, or special purpose district; 2. consolidation of special purpose districts, but not including consolidation of cities and towns; or 3. dissolution or disincorporation of any city, town, or special purpose district, except the dissolution or disincorporation of a special purpose district which was dissolved or disincorporated pursuant to the provisions of chapter 36.96 RCW; or
- B. The assumption by any city or town of all or part of the assets, facilities, or indebtedness of a special purpose district which lies partially within such city or town; or
- C. The establishment of or change in the boundaries of a mutual water and sewer system or separate sewer system by a water district pursuant to RCW 57.08.065 or chapter 57.40 RCW, as now or hereafter amended; or
