AN ORDINANCE relating to the annexation of an area known as Scheumann to Woodinville Water District .

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Scheumann to Woodinville Water District was filed with the county council effective December 11, 1987.

SECTION 1. The annexation by Woodinville Water District of the area known as Scheumann and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Scheumann.

SECTION 2. Woodinville Water District is the appropriate entity to serve the area proposed to be annexed.
