ORDINANCE NO. 8404

AN ORDINANCE transferring \$13,440,684 to the Solid Waste Construction - 1987 Fund from the Solid Waste Construction - 1981 Fund; and appropriating \$1,894,755 to the Solid Waste Construction - 1987 Fund for Project 063036, Cedar Grove Road, to reimburse the County Road Construction Fund for expenses incurred in constructing the Cedar Grove Road; and amending Ordinance No. 7864, Sections 64 and 75, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a transfer of \$13,440,684 to the Solid Waste Construction - 1987 Fund from the Solid Waste Construction - 1981 Fund for the following projects: No. 003087 Bow Lake Repair (\$501,482); No. 003093 Cedar Hills Leachate Head Reduction (\$3,598,240); No. 003094 Cedar Hills Southeast Pit Reconstruction (\$1,786,656); No. 003095 Cedar Hills Active Gas Collection (\$1,362,534); No. 003096 Cedar Hills Aeration Basin Upgrade (\$532,376); No. 003097 Cedar Hills Retention/Detention (\$1,100,000); No. 003098 Cedar Hills-Maple Valley Force Main (\$1,500,000); No. 003100 Transfer Station Facilities Upgrade (\$1,200,000); No. 003108 Cedar Hills Pump Station I Construction (\$859,876); No. 003109 Cedar Hills South Leachate Collector (\$826,270); No. 003110 Algona Sewer Construction (\$173,250); for the purpose of meeting accounting requirements associated with the sale of the 1987 Solid Waste Construction Fund proceeds.

SECTION 2. There is hereby approved and adopted an appropriation of \$1,894,755 to the Solid Waste Construction - 1987 Fund for Project 063036, Cedar Grove Road, to reimburse the County Road Construction Fund for expenses incurred in constructing the Cedar Grove Road.

SECTION 3. There is hereby approved and adopted a transfer of \$400,000 to the Solid Waste Construction - 1987 Fund from the Solid Waste Fund for Project 063036, Cedar Grove Road, to recognize the payment received from the City of Seattle for this project.

SECTION 4. Ordinance No. 7864, Section 64, as amended, is hereby amended by adding thereto and inserting the following:

From the Solid Waste Fund there is hereby appropriated to:

Solid Waste \$400,000

SECTION 5. Ordinance No. 7864, Section 75, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Sections 1 and 2 of this ordinance.
