4 ORDINANCE NO. 8505

5 AN ORDINANCE relating to the annexation of an
6 area known as 81-69-30 to Southwest Suburban
7 Sewer District.

8 STATEMENT OF FACT:

9 1. A notice of intention proposing the annexation of an area
10 known as 81-69-30 to Southwest Suburban Sewer District was filed
11 with the county council effective March 25, 1988.

12 2. Southwest Suburban Sewer District has found the petition
13 for annexation to be sufficient and has, by Resolution No. 87-46
14 concurred with the proposed annexation.

15 3. Southwest Suburban Sewer District filed a Declaration of
16 Non-significant Impact dated February 22, 1988, on the proposed
17 annexation.

18 4. The county council held a public hearing on the 9th day
19 of May, 1988 and has considered the criteria set
20 forth in R.C.W. 56.02.060.

21 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

22 SECTION 1. The annexation of Southwest Suburban Sewer
23 District of the area known as 81-69-30 and described in Section 4
24 herein is approved. This proposed annexation is consistent with
25 R.C.W. 56.02.060 as described in the attached King County Council
26 Annexation Report on 81-69-30.

27 SECTION 2. The Southwest Suburban Sewer District is the
28 appropriate entity to serve the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not constitute
2 county approval or disapproval of any other permits, franchises,
3 certifications, or actions necessary to provide service to this
4 annexation area, nor does it authorize sewer service in any area
5 not designated as a "Local Service Area" by the King County
6 Sewerage General Plan.

7 SECTION 4. The area known as 81-69-30 to be annexed is
8 described as follows:

9 That portion of land described as the Southeast 1/4 of the
10 Northeast 1/4 of Section 30, Township 23 North, Range 4 East,
W.M., except the south 30 feet of the east 691 feet thereof.
