ORDINANCE NO. 8567

AN ORDINANCE relating to the annexation of an area known as P-305S to Soos Creek Water and Sewer District for sewer service only.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as P-305S to Soos Creek Water and Sewer District was filed with the county council effective May 19, 1988.

2. Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0159S concurred with the proposed annexation.

3. Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated March 3, 1988, on the proposed annexation.

4. The county council held a public hearing on the 27th day of June, 19 88 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District of the area known as P-305S and described in Section 4 herein is approved for sewer service only. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on P-305S.

SECTION 2. The Soos Creek Water and Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as P-305S to be annexed is

described as follows:

Beginning at the Northwest corner of the Northeast quarter of the Northeast quarter of Section 22, Township 22 North, Range 5 East, W.M., in King County, Washington, said point being on the centerline of S.E. 240th Street said point also being on the existing Soos Creek Water and Sewer District boundary;

Thence Easterly and Southeasterly along said centerline of S.E. 240th Street to the East line of said Section 22 also being the West line of Section 23, Township 22 North, Range 5 East, W.M., in King County, Washington;

Thence continuing Southeasterly along said centerline of S.E. 240th Street to its intersection with the centerline of 148th Place S.E.;

Thence Southerly along said centerline of 148th Place S.E. to its intersection with the Northeast corner of the Northeast quarter of the Southeast quarter of said Section 22;

Thence Westerly along the North line of said Northeast quarter of the Southeast quarter to its intersection with the East line of the West half of the Northeast quarter of said Section 22;

Thence Northerly along said East line to said Northwest corner of said Northeast quarter of the Northeast quarter of said Section 22, and the Point of Beginning.
