AN ORDINANCE appropriating \$49,693 to various county agencies and departments in support of the new change of venue court calendar from Special Programs - Executive Contingency in the Current Expense Fund and amending Ordinance 8331, Sections 26, 28, 34, 44, and 46, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$49,963 to various county agencies and departments in support of the new change of venue court calendar, from Special Programs - Executive Contingency, in the Current Expense Fund.

SECTION 2. Ordinance 8331, Section 26, as amended, is hereby amended by adding thereto and inserting therein, the following:

PROSECUTING ATTORNEY - From the Current Expense Fund, there is hereby appropriated to:

SECTION 3. Ordinance 8331, Section 28, as amended, is hereby amended by adding thereto and inserting therein, the following:

DISTRICT COURT - From the Current Expense Fund, there is hereby appropriated to:

District Court \$12,500

SECTION 4. Ordinance 8331, Section 46, as amended, is hereby amended by adding thereto and inserting therein the following:

ADULT DETENTION - From the Current Expense Fund, there is hereby appropriated to:

Adult Detention \$4,713

8 SPECIAL PROGRAMS - EXECUTIVE CONTINGENCY - From the Current
9 Expense Fund, there is hereby disappropriated from:

10 Special Programs - Executive Contingency (\$49,693)

11 Provided that:

12 By September 1, 1988, the Executive shall submit to the
13 council the following:

14 A. For a two-month period prior to inception of the change
15 of venue court, and for defendants appearing before the change of
16 venue court in October, 1987 and March, 1988, the Executive shall
17 collect data on:

18 1. The average time elapsed between the time of booking
19 and initial court appearance.

20 2. The average time elapsed between the time of initial
21 court appearance and disposition of the case.

22 3. The data referenced in A.1 and A.2 above shall be of
23 misdemeanants who have had their cases disposed of or have had a
24 bail hearing.

25 4. The data referenced in A.1 and A.2 above for the two
26 months prior to inception of the change of venue court shall be
27 collated by the court to which the defendant was transported for
28 their initial court hearing.

5. The data referenced in A.1 and A.2 above for October, 1987 and March, 1988 shall be collated by the court to which the defendant would have been transported if the change of venue court had not been in existence.
