Provided that:

By September 1, 1988, the Executive shall submit to the council the following:

- A. For a two-month period prior to inception of the change of venue court, and for defendants appearing before the change of venue court in October, 1987 and March, 1988, the Executive shall collect data on:
- 1. The average time elapsed between the time of booking and initial court appearance.
- 2. The average time elapsed between the time of initial court appearance and disposition of the case.
- 3. The data referenced in A.1 and A.2 above shall be of misdemeanants who have had their cases disposed of or have had a bail hearing.
- 4. The data referenced in A.1 and A.2 above for the two months prior to inception of the change of venue court shall be collated by the court to which the defendant was transported for their initial court hearing.

2	1987 and March, 1988 shall be collated by the court to which the
3	defendant would have been transported if the change of venue
4	court had not been in existence.
