ORDINANCE NO. 8638

AN ORDINANCE relating to the withdrawal of territory of an area known as 352 A to Eastgate Sewer District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the withdrawal of territory of an area known as 352 A to Eastgate Sewer District was filed with the county council effective August 2, 1988.
- Eastgate Sewer District has found the petition for withdrawal of territory to be sufficient and has, by Resolution No. 646 concurred with the proposed withdrawal of territory.
- 3. Eastgate Sewer District filed a Declaration of Non-significant Impact dated June, 1988, on the proposed withdrawal of territory.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The withdrawal of territory of Eastgate Sewer District of the area known as 352 A and described in Section 4 herein is approved. This proposed withdrawal of territory is consistent with R.C.W. 56.02.060 as described in the attached King County Council Withdrawal Report on 352 A.

SECTION 2. Completion of this withdrawal of territory does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this withdrawal of territory area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

Beginning at the Southwest corner of Section 23, Township 24 North, Range 5 East, W.M.;

Thence Easterly along the South line of said Section 23 to its intersection with the East line of said Section 23;

Thence Northerly along said East line to its intersection with the South line of the North 1/2 of the Southeast 1/4 of said Section 23;

Thence Westerly along said South line to its intersection with the Southeasterly margin of Lakemont Boulevard Southeast;
