ORDINANCE NO. 8652

AN ORDINANCE relating to the annexation of an area known as DS-88-3 to Des Moines Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS-88-3 to Des Moines Sewer District was filed with the county council effective July 14, 1988.

2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1988-11 concurred with the proposed annexation.

3. Des Moines Sewer District filed a Declaration of Non-significant Impact dated June 29, 1988, on the proposed annexation.

4. The county council held a public hearing on the 12th day of September, 1988 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Des Moines Sewer District of the area known as DS-88-3 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on DS-88-3.

SECTION 2. The Des Moines Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

1 SECTION 4. The area known as DS-88-3 to be annexed is described
2 as follows:

3 Beginning at the North 1/4 corner of Section 20, Township 22
4 North, Range 4 East, W.M.,

5 Thence Westerly along the North line of said Section 20 to its
6 intersection with the line of extreme low tide of Puget Sound;

7 Thence Southerly along said line of extreme low tide to its
8 intersection with the Westerly extension of the North line of
9 Lot 21, Block 64 of Des Moines Water Front Addition to the
10 Town of Des Moines, according to plat thereof recorded in
11 volume 4 of plats, page 96, records of King County, Washington;

12 Thence Easterly along said North line and its Westerly
13 extension and the North line of Lot 21, Block 63; Lot 21,
14 Block 61; and Lot 21, Block 60, and its Easterly extension to
15 its intersection with the centerline of 8th Avenue South;

16 Thence Southerly along said centerline to its intersection
17 with the centerline of South 246th Street;

18 Thence Easterly along said centerline to its intersection with
19 the centerline of Marine View Drive South (Secondary State
20 Highway I-V);

21 Thence Northerly along said centerline to its intersection
22 with the North line of said Section 20;

23 Thence Westerly along said North line to the said North 1/4
24 corner of Section 20 and the Point of Beginning.
