ORDINANCE NO. 8653

AN ORDINANCE relating to the annexation of an area known as DS-88-1 to Des Moines Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS-88-1 to Des Moines Sewer District was filed with the county council effective July 14, 1988.

2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1988-12 concurred with the proposed annexation.

3. Des Moines Sewer District filed a Declaration of Non-significant Impact dated June 29, 1988, on the proposed annexation.

4. The county council held a public hearing on the 12th day of September, 1988 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Des Moines Sewer District of the area known as DS-88-1 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on DS-88-1.

SECTION 2. The Des Moines Sewer District is the appropriate entity to serve the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not constitute
 2 county approval or disapproval of any other permits, franchises,
 3 certifications, or actions necessary to provide service to this
 4 annexation area, nor does it authorize sewer service in any area
 5 not designated as a "Local Service Area" by the King County
 6 Sewerage General Plan.

7 SECTION 4. The area known as DS-88-1 to be annexed is
 8 described as follows:

9 That portion of the NE 1/4 of the NW 1/4 of Section 34,
 10 Township 23 North, Range 4 East, W.M., described as follows:

11 Beginning at the intersection of the North line of the said NE
 12 1/4 with the centerline of 42nd Avenue South;

13 Thence Southerly along said centerline to its intersection
 14 with the centerline of South 179th Street;

15 Thence Westerly along said centerline to its intersection with
 16 the centerline of 38th Avenue South;

17 Thence Northerly along said centerline to its intersection
 18 with the North line of the said NE 1/4 of the NW 1/4 of
 19 section 34;

20 Thence Easterly along said North line to its intersection with
 21 the centerline of 42nd Avenue South and the Point of Beginning.

22 INTRODUCED AND READ for the first time this 18th day
 23 of July, 1988.
