AN ORDINANCE relating to the annexation of an area known as P-88-1W-R to Soos Creek Water and Sewer District, for water service only.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as P-88-1W-R to Soos Creek Water and Sewer District for water service only, was filed with the county council effective September 7, 1988.

2. Soos Creek Water and Sewer District for water service only, has found the petition for annexation to be sufficient and has, by Resolution No. 0215-W concurred with the proposed annexation.

3. Soos Creek Water and Sewer District for water service only, filed a Declaration of Non-significant Impact dated July 7, 1988, on the proposed annexation.

4. The county council held a public hearing on the 26th day of September, 1988 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Soos Creek Water and Sewer District for water service only, of the area known as P-88-1W-R and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on P-88-1W-R.

SECTION 2. Soos Creek Water and Sewer District for water service only, is the appropriate entity to serve the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not constitute
 2 county approval or disapproval of any other permits, certifica-
 3 tions, or actions necessary to provide service to this annexation
 4 area.

5 SECTION 4. The area known as P-88-1W-R to be annexed is
 6 described as follows:

7 That portion of Section 16, Township 22 North, Range 5
 8 East, W.M., King County, Washington, more particularly
 9 described as follows:

10 Beginning at the Northwest corner of the Southwest quarter
 11 of the Northwest quarter of said Section 16;

12 Thence Southerly along the West line of said Southwest
 13 quarter to the South line of the North half of the South
 14 half of said Southwest quarter;

15 Thence Easterly along said South line to the West line of
 16 the East half of the West half of the West half of said
 17 Section 16;

18 Thence Northerly along said West line to the South line of
 19 the Northwest quarter of the Northwest quarter of said
 20 Section 16;

21 Thence Westerly along said South line (which is also the
 22 North line of the Southwest quarter of the Northwest
 23 quarter of said Section 16) to the Point of Beginning.
