

ORDINANCE NO. 8758

AN ORDINANCE relating to vehicle parking adjacent to the Kingdome; setting the parking rate and hours of availability in the north and south parking lots; amending Ordinance No. 7017, Section 4, as amended, and K.C.C. 22.12.030.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 7017, Section 4, as amended, and K.C.C.

22.12.030 are each hereby amended to read as follows:

Parking

A. Daily Parking Fees

Any person parking a vehicle in the Kingdome parking lot on a daily basis will pay according to the following schedule:

1. Non-Event Day parking:

Days, 0 to 3 hours, north parking lot ~~\$(2)~~ 3.00 per parking stall

(includes sales tax)

Days, over 3 hours, north parking lot ~~\$(4)~~ 5.00 per parking stall

(includes sales tax)

Evenings, north parking lot ~~\$(2)~~ 3.00 per parking stall

(includes sales tax)

Evenings, south parking lot \$2.00 per parking stall

(includes sales tax)

Days, south parking lot \$2.00 per parking stall

(includes sales tax)

Daily parking is subject to availability, as determined by the director of the department of stadium administration.

2. Event Day Parking:

Estimated attendance of 30,000 or less:

Vehicles under 23 feet in length	\$4.00 per event
	(includes sales tax)
Vehicles 23 feet in length and over	\$8.00 per event
	(includes sales tax)
Buses	\$10.00 per event
	(includes sales tax)

Estimated attendance over 30,000:

<u>Vehicles under 23 feet in length</u>	<u>\$5.00 per event</u>
	<u>(includes sales tax)</u>
<u>Vehicles 23 feet in length and over</u>	<u>\$9.00 per event</u>
	<u>(includes sales tax)</u>
<u>Buses</u>	<u>\$11.00 per event</u>
	<u>(includes sales tax)</u>

B. Monthly Parking Fees

Any person or organization choosing to park a vehicle in the Kingdome north parking lot on a monthly basis, will pay according to the following schedule.

1. Individual Rate	((\$40))	\$55 per parking stall
		(plus sales tax)

The individual rate allows parking from 5:00 a.m. to 12:00 ~~((a.m.))~~ midnight on non-event days; parking is also permitted on event days based on times established by the stadium's department director.

((2. -- Group Rate	(\$35 per parking stall
	(plus sales tax)

~~The group rate allows any person or organization using five or more parking stalls to park from 5:00 a.m. to 12:00 a.m. on non-event days; parking is also permitted on event days based on times established by the stadium's department director.)~~

((3. -- Unrestricted Rate	\$50 per parking stall
	plus sales tax

1 The unrestricted rate allows parking from 5:00 a.m. to 12:00 a.m. on
 2 all non-event and event days.))

3 2. Carpool Parking ~~(\$17.50)~~ \$20 per month for 3 or
 4 more persons

5 (plus sales tax)

6 ~~(\$27.50)~~ \$30 per month for 2-person
 7 carpools

8 (plus sales tax)

9 The car pooling rate allows parking from 5:00 a.m. to 12:00 midnight on
 10 non-event days. Parking is also permitted on event days based on times
 11 established by the stadium administration department director.

12 Provided that:

13 The daily and monthly parking fees established in this section will not
 14 apply to any person or organization whose parking fees are established under
 15 a separate negotiated contract between the department of stadium
 16 administration and said person or organization.

C. Effective date. The effective date of this section is January 1, 1989 (~~January 1, 1987~~).
