ORDINANCE NO. **8759**

AN ORDINANCE appropriating funds in the amounts of \$981,291 to the Solid Waste Construction - 1981 Fund and \$3,901,939 to the Solid Waste Construction - 1987 Fund; for costs to contract for completion of the Cedar Hills Site Development Plan, and to provide for additional costs for the following projects: Cedar Hills-Maple Valley Force Main, Cedar Hills Pump Station 1 Construction, Cedar Hills South Leachate Collector, and Hobart Landfill Closure, and amending Ordinance No. 8331, Section 80, and 81, Attachment 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$981,291 to the Solid Waste Construction - 1981 Fund, to provide for consulting costs for CIP Project 003081, Cedar Hills Site Development Plan, in the amount of \$550,000; and for CIP Project No. 003118, transfer to fund 3030, in the amount of \$431,291, from \$70,250 of unencumbered fund balance and the following project disappropriations: CIP Project No. 003083, Cedar Hills Area 2/3 Design, in the amount of \$47,608; CIP Project No. 003080, Enumclaw Leachate Control, in the amount of \$48,043; CIP Project No. 003082, Cedar Hills Central Pit Construction, in the amount of \$494,015; CIP Project No. 003084, Maple Valley Sewer Repair, in the amount of \$50,000; CIP Project No. 003085, Cedar Hills Leachate System Evaluation, in the amount of \$34,486; and CIP Project No. 003092, Cedar Hills North Leachate Collector, in the amount of \$236,889.

1 SECTION 2. There is hereby approved and adopted an
 2 appropriation of \$3,901,939 to the Solid Waste Construction -
 3 1987 Fund, to provide for costs associated with the following
 4 capital projects; CIP Project No. 013098, Cedar Hills-Maple
 5 Valley Force Main, in the amount of \$1,016,000; CIP Project No.
 6 013108, Cedar Hills Pump Station 1 Construction, in the amount of
 7 \$726,204; CIP Project No. 013109, Cedar Hills South Leachate
 8 Collector, in the amount of \$1,089,735; and CIP Project No.
 9 003116, Hobart Landfill Closure, in the amount of \$1,070,000,
 10 from a transfer of \$431,291 from the Solid Waste Construction -
 11 1987 Fund, and a disappropriation of \$140,709 from
 12 underexpenditures in CIP Project No. 013094, Cedar Hills
 13 Southeast Pit Reconstruction. The remaining funding of
 14 \$3,329,939 shall be provided by a future transfer from bond
 15 proceeds anticipated in 1989. Expenditures prior to the
 16 establishment of this future bond fund shall be made from
 17 unencumbered fund balance from Fund 3030, Solid Waste
 18 Construction - 1987 Fund.

19 SECTION 3. Ordinance 8331, Section 80, Attachment 1, as
 20 amended, is hereby amended by adding thereto and inserting
 21 therein the following:

23 From the several capital improvement project funds there are
 24 hereby appropriated and authorized to be disbursed the following
 25 amounts for the specific projects identified in Attachment No. 1,
 26 as adjusted by Attachment No. 2, of this ordinance.
